2. English and Southeastern construction work- There are a handful of projects in this area.
  - a. CW-25-006 - This is a crosswalk improvement project that is in design. The focus is improving ADA ramps, signage and signals of pedestrian crosswalks and potentially installing flashing beacons where necessary. This project improves existing infrastructure. Construction is expected to begin in 2024.
  - b. GT-33-001 - This is the Southeastern Ave. multi-use trail from Washington to the CJC. This project is also in design with a 2024 construction schedule.
  - c. ST-21-105 - This is a road restoration project surrounding the Rural and Southeastern roundabout. Construction is scheduled to be completed by July. They're currently working on the portion of English. The following streets are included in the reconstruction:
    - i. Southeastern
      1. Temple to Oxford
      2. Oxford to railroad crossing
    - ii. Pleasant Run Parkway
      1. Keystone to slightly east of Keystone
      2. CJC entrance to Dearborn
    - iii. Rural
      1. South of roundabout to north of roundabout
    - iv. English
      1. Leads to Dearborn

- d. ST-22-099 - This is a residential street reconstruction project that councilors help select streets. The following streets are included:
      - i. Spann from Laurel to State
      - ii. Clayton from Rural to Oakland
      - iii. Spann from Grant to Kingbridge
    - e. Residents can request streetlights via the MAC. DPW then collaborates with AES on installation.
      - i.
  3. We discussed sidewalk repairs in our meeting, and Lane mentioned that DPW Operations can only fix two panels. Anything larger is sent to DPW Engineering to be programmed into larger projects. Of course, reporting these damages to the MAC is a great way of creating the initial report. The INIP program is a way of funding new sidewalks if there are collective neighborhood funds, and new developers are held accountable for building new sidewalks as well.
  4. Lane did not have any information about Clayton and La Salle Park. He will have to connect with Indy DMD and Indy Parks for more info.
  5. Kate Voss, SEND Community Builder mentioned traffic calming in Barrington and South Meridian. Lane reports the best way to do that is through the Tactical Urbanism policy or Street Change policy. Those are both here: <https://www.indy.gov/activity/public-works-specifications-and-manuals>. If it's an enforcement issue with speeding, we may need to reach out to IMPD for assistance.

# REENTRY: REDUCING RECIDIVISM

The Reentry Division aims to increase equitable access to resources for the Marion County Reentrant community in an effort to reduce the likelihood of recidivism.

We partner with the Community Justice Campus, PACE, Unite Indy, Neighborhood Christian Legal Clinic, Recycle Force, Fastenal, and others to provide:

- Release Lobby at the CJC - 24/7 assistance to connect those individuals exiting the jail with employment, food, and housing assistance.
- Hosting Community events
- Provide support the reentrant community through barrier removal services such as Expungement Clinics, Drivers License Renewal, Employment opportunities, Housing searches, access to life coaching, and more





# BEHAVIORAL HEALTH

Addressing mental health and substance use issues. Emphasizing access to treatment, trauma-informed crisis response, and removing stigmas

## Assessment & Intervention Center

- Non-medical, 24/7 voluntary referral linkage facility
- Managed in partnership with Sandra Eskenazi Mental Health Centers, OPHS, and the Community Justice Campus
- Provides free mental health and addiction assessments and referrals
- Call: 317-327-8733

## Clinician-Led Community Response Team

- Non-law enforcement, emergency response team
- Comprised of Licensed Clinician Social Workers and Peer Specialists
- Responds to 911 calls meeting specific mental-health criteria outlined by emergency services





# COMMUNITY VIOLENCE REDUCTION

In 2021, Mayor Hogsett announced a three-year, \$150 million violence reduction strategy. At the core of this plan are our peacemakers of the **Indy Peace Fellowship**. This partnership between OPHS and the Indy Public Safety Foundation (IPSF) works to identify, connect, and serve individuals at high risk of gun violence.



## Peacemakers

The Indy Peace Fellowship is led by those who live in the community to serve those in their community. The Peacemakers are outreach workers, violence interrupters, and life coaches who work directly with high-risk individuals in communities experiencing violence. They are part of the communities they represent, using their skills, experiences, and knowledge to help reduce gun violence in Indianapolis.

## Community Based VP Partnership Grants

This OPHS grant is designed to support the existing efforts of local community organizations to address violence and increase safety, especially in those areas of Indianapolis that have experienced recent increases in violent crime.

## Elevation Grantees

Administered by the Indianapolis Foundation, the Elevation Grant Program is funded with \$45 million over three years invested in grassroots organizations. The desired outcomes include: addressing root causes of violent crime, community building, and elevating opportunities that foster hope, abundance, peace, resiliency, and safety.



## Summer in The City

Free, positive, meaningful, and educational experiences for youth that may normally not be exposed to this type of programming during the summer months. Programming available Mon-Fri starting June 5.

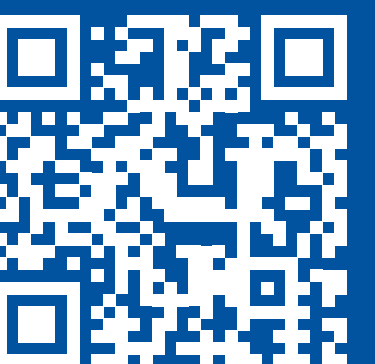

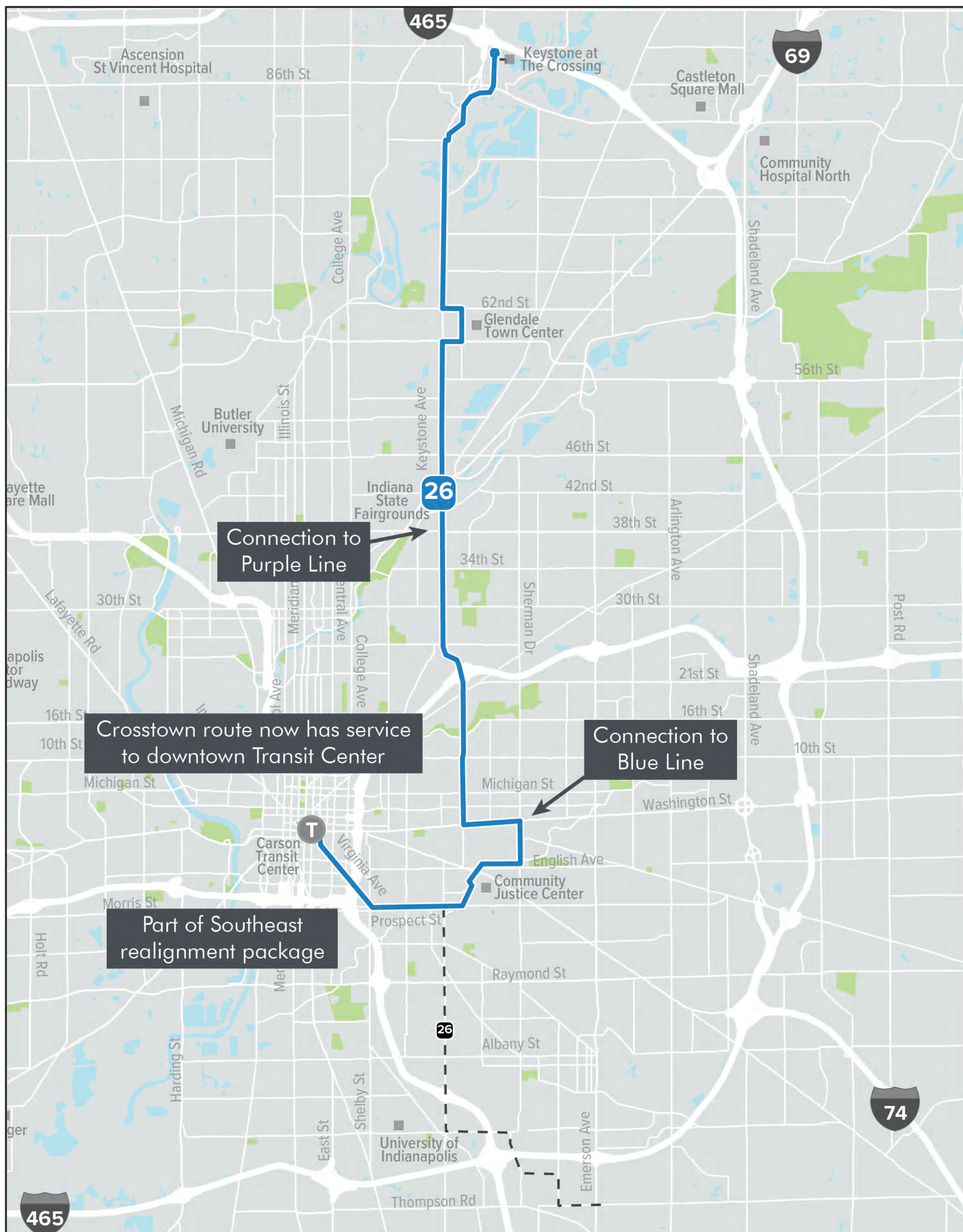

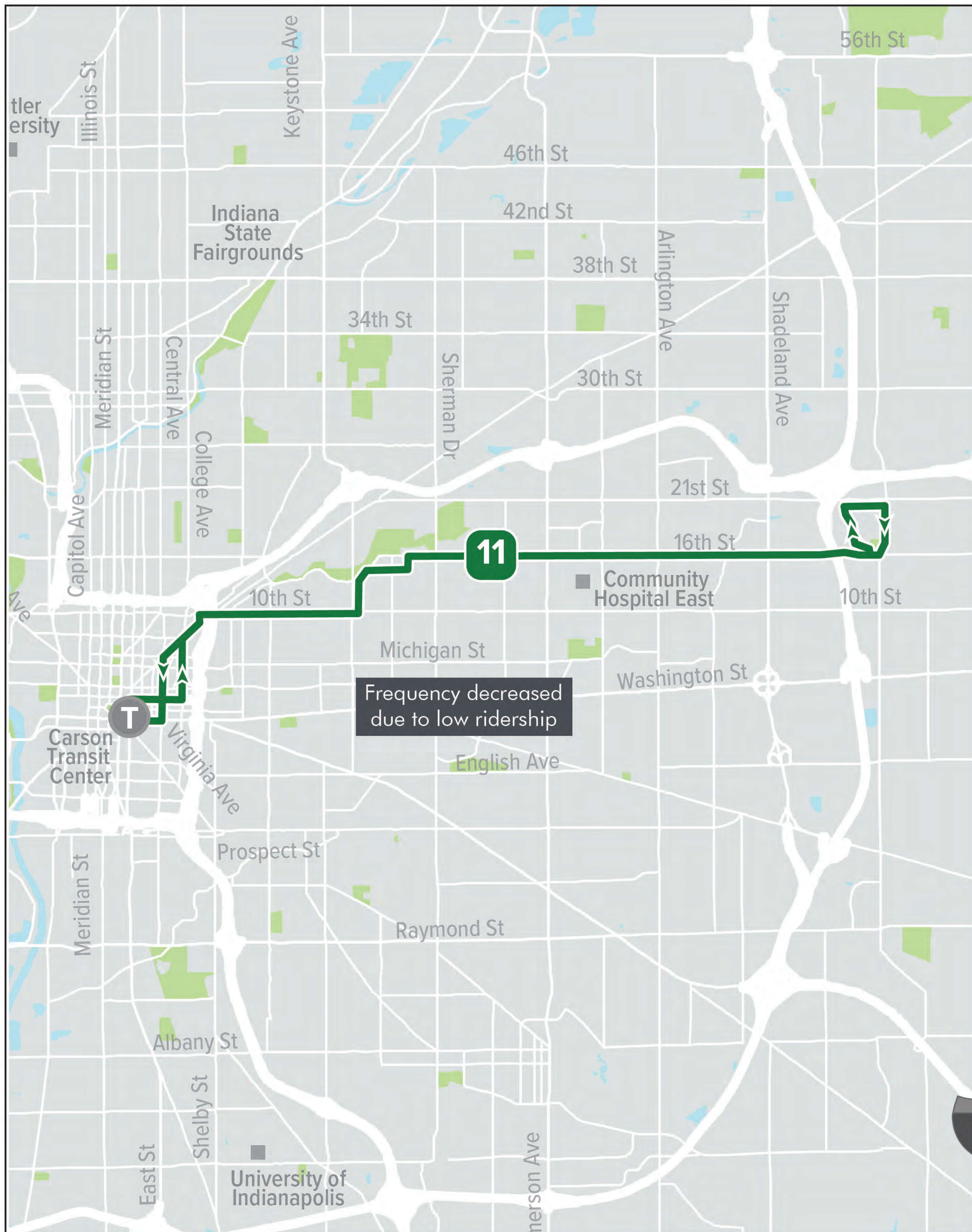

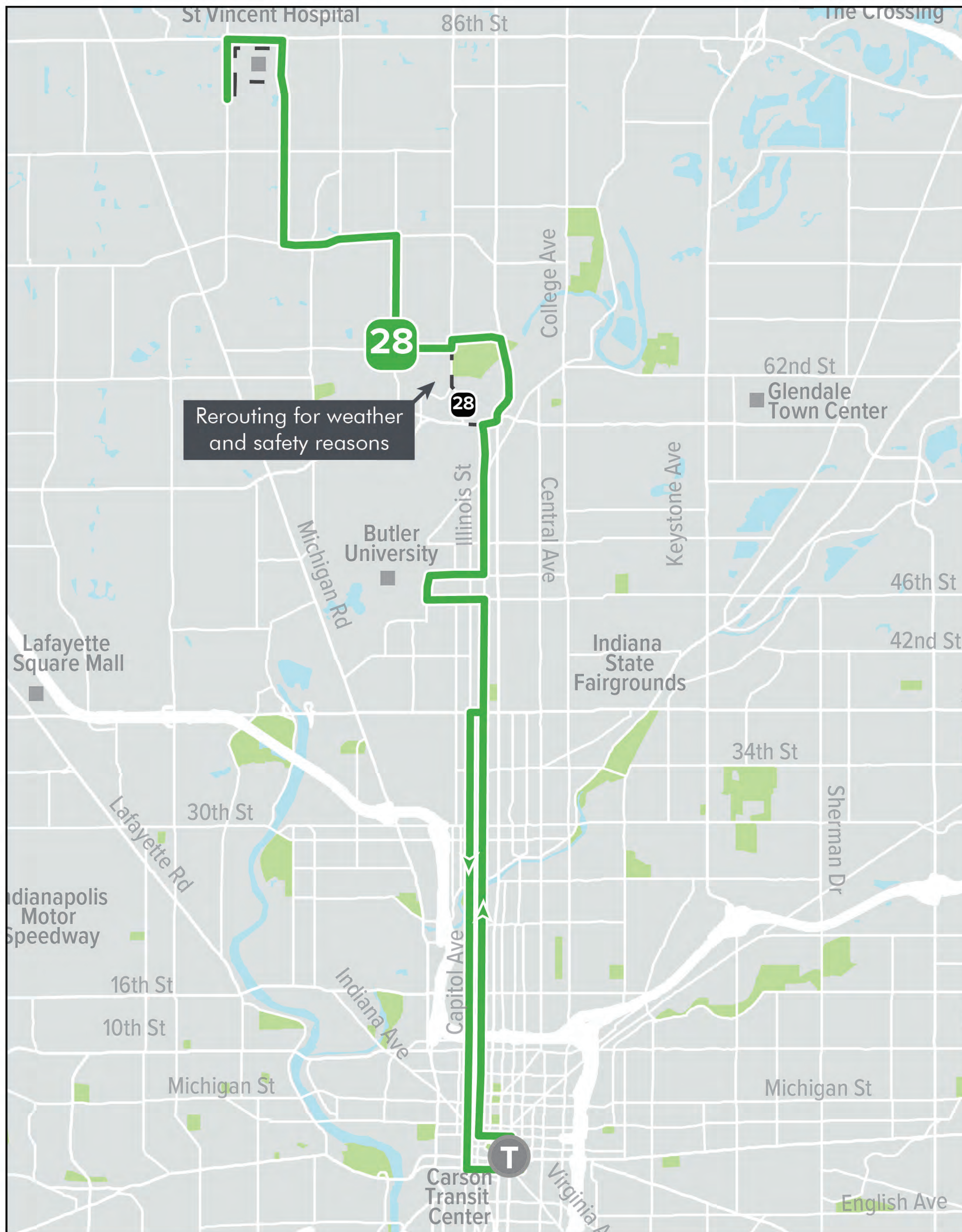

# ROUTES 14, 26, 55, & 56 MODIFICATION

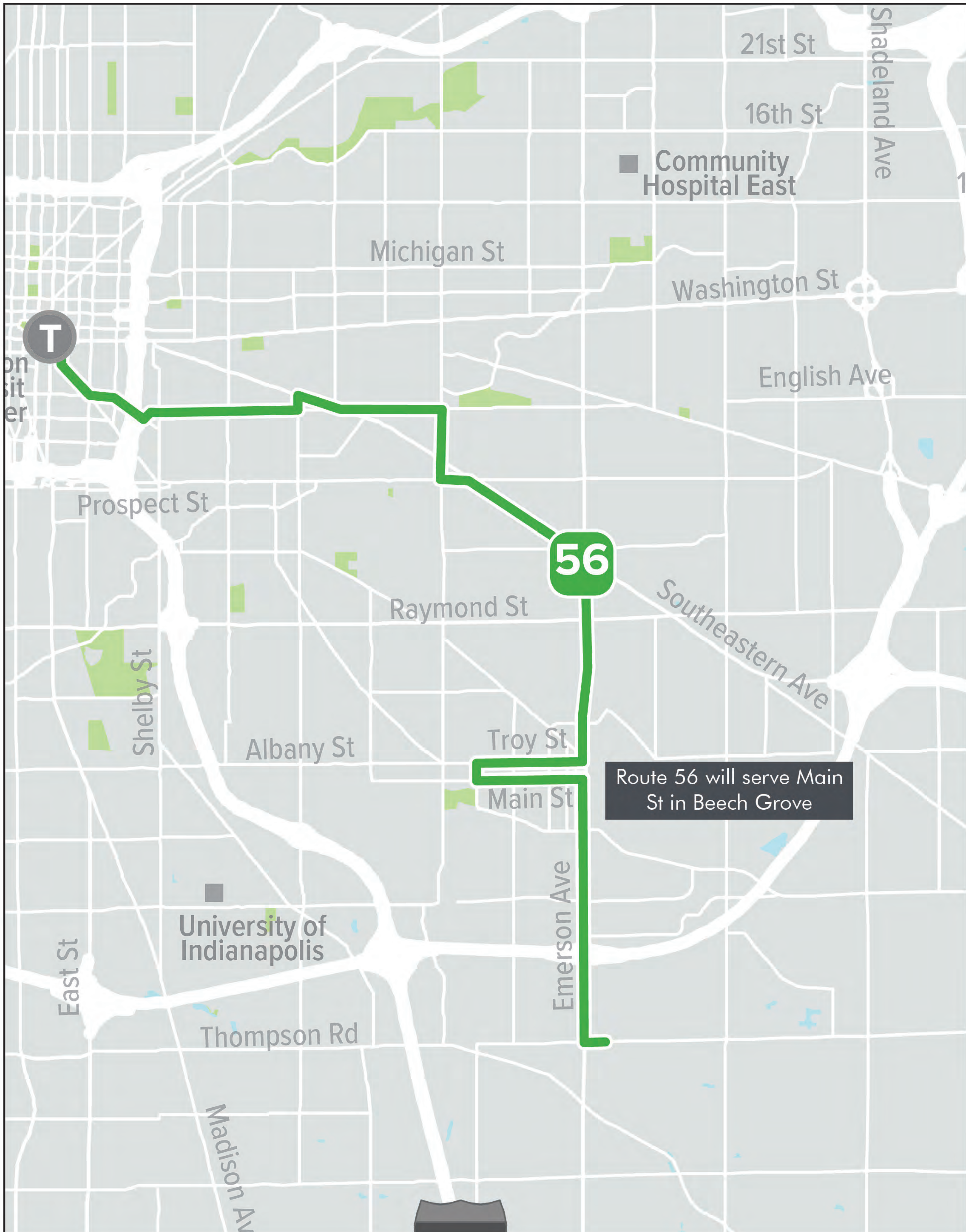

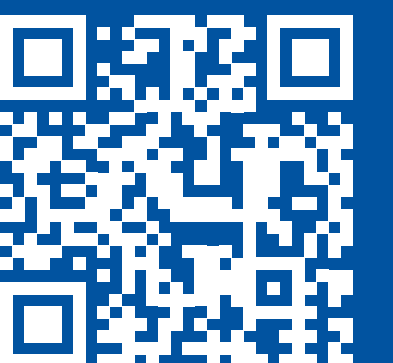

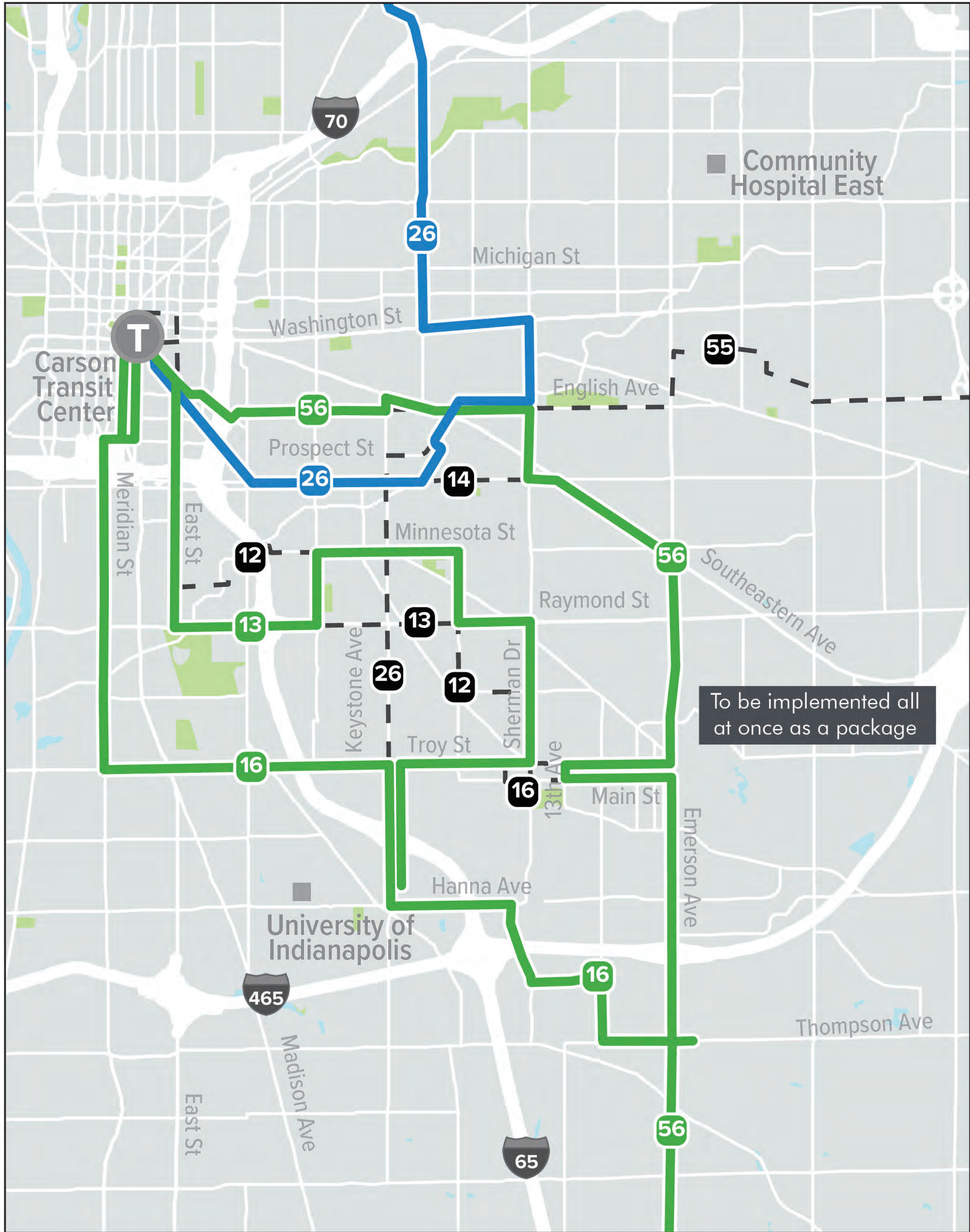
